Article 7 of Chapter II of the Constitution of the Republic of Liberia provides for the full public participation of all citizens in the protection and management of the environment and natural resources of Liberia. In fulfillment of this constitutional mandate, the Act creating the Environment Protection Agency of Liberia (EPA) was passed in 2003. The EPA as the national environmental regulatory agency has the mandate to ensure the sustainable management of the environment and its natural resources through collaboration with relevant line Ministries, Agencies, Commissions, and Organizations (MACOS) and in a close and responsive relationship with the people of Liberia.

Pursuance to the realization of the above objects, the Environmental Protection and Management Law (EPML) was concomitantly enacted to provide for the enforcement of the provisions of the EPA Act. Section 37 of said Act empowers the Agency to require the conduct of environmental impact assessment by any proponent/project developer who intends to undertake any activity that may have may or may not have a significant impact on the environment. Section 29 of the EPML, which is in observance of Section 37 mentioned supra, empowers the Agency to charge fees for the permitting processes and related administrative costs. The said Section reads:

- 1) The Agency shall be entitled to charge fees under a scheme of charges to be approved by the Board;
- 2) The fees shall be no more than needed to enable the Agency to recover its justifiable costs from year to year of administering the approval process;
- 3) There shall be a different scale of fees for applicants for approval of a project which is determined not to require an environmental impact assessment from one which does;
- 4) In drawing up the scheme of charges, the Agency shall not be required to charge only the actual costs involved in approving each project, but shall be entitled to impose average charges except that, it may impose an additional charge from applications of particular complexity or demands of time and resources.

In exercise of the powers and authorities conferred on the Environment Protection Agency (EPA) of the Republic of Liberia, by Section 29 of the Environmental Protection and Management Law, 2003, the following Regulations are hereby approved.

Short title

These Regulations may be cited as the Environmental and Social Impact Assessment Permitting Fees Regime, 2020.

Application for Permit

- A. Any project proponent/developer who plans to undertake or cause to be undertaken, any of the projects outlined in **Annex I, Section 6** of the Environment Protection and Management Law, 2003; in fulfillment of the requirements of **Section 37** of the Environmental Protection Agency Act, 2003, shall apply to the Agency for an environmental permit and/or license.
- B. The application shall be in the form as set out in Schedule I of these Regulations.
- C. The application shall be accompanied by a concise description of the project or activities to be undertaken, which description shall include all information set

out in Schedule I and any additional requirements by the EPA as may be deemed necessary for the processing of the permit and/or license applied for.

Issuance of Permit

Upon the review of an application and its accompanying requirements, if any, the Agency shall make a decision (approve, conditionally approve, return application/project Brief/ESIA report, EMP, ESMP, EAF, EAR, ERP, ESR, RAP, IEA, RPF, CAs, etc. for the request of additional information or deny) on the issuance of a permit in the form and manner as outlined in Section 21 of the Environmental Protection and Management Law, 2003, which states that the Agency may:

1. Approve the project or activity unconditionally if it is satisfied that the project or activity shall not result in significant damage to the environment;
2. Approve the application conditionally by requiring the developer to redesign the project or do such other things as the Agency considers necessary, taking into consideration the suggestions or comments made and all environmental factors; or
3. Refer the application back to the applicant for further study or submission of additional information;
4. Reject the application where it believes that said project may cause a significant or irreversible damage to the environment or human health.

Monitoring

- A. The Agency shall supervise, compliance monitor, and conduct an environmental audit when deemed necessary, all activities of project proponent to ensure compliance with all permitting terms and conditions as required by the EPA Act.
- B. To ensure full compliance with requirements of the Act, monitoring of any project activities shall take into consideration factors including but not limited to:
 - a. The intensity of the potential impacts of the project on the environment;
 - b. The intensity of the potential impacts of the project on the socio-economic life of the Project Affected Communities (PACs);
 - c. The complexity of the nature of the project;
 - d. The complexity of the project site;
 - e. The size of the amount of land the project is to occupy;
 - f. Other potential impacts such as (adverse, direct, indirect, cumulative, positive) of the project are readily undetectable at the time of the processing of the permit.


